HEREBY AGREE that I am by agreement entitled to participate in the Tractor Pull activity on the terms and conditions set out in this document.

Acknowledgement of Risks, Dangers and Obligations.

I ACKNOWLEDGE that the sport of Tractor pulling is dangerous and that by engaging in the sport and participating in (The Meeting) I take, and am exposed to, certain risks and dangers, and am under certain obligations as follows—

- (a) That I may be injured, physically or mentally, and I may be killed;
- (b) That my machinery or equipment may be lost, damaged or destroyed;
- (c) That other competitors may control machinery dangerously and with lack of skill;
- (d) That track or event conditions may be hazardous and may vary without warning or predictability;
- (e) That organizers, equipment owners, officials, landowners, track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time and/or events;
- (f) That there may be no or inadequate facilities for treatment or transport of me if I am injured;
- (g) That I have an obligation to myself and to others to compete safely and within the Rules of Competition.

Indemnity Given to Organisers, equipment owners, officials, landowners, track operators and any agents or representatives of those in charge.

- (c) That I indemnify and hold harmless the organizers, equipment owners their respective servants, agents or officials against any actions or claims which may be made by me or on my behalf or by other parties for or in request of or arising out of my death or any injury loss or damage caused to me or to my machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
